- <u>CALL FOR PAPERS</u>: The <u>Disability and Health Journal (DHJO</u>) is planning an <u>online-only special</u> <u>supplement issue dedicated to Community Living Policy</u>, guest edited by Joe Caldwell and Ari Ne'eman.
 - a. We invite submission of original research papers. We seek papers that focus on focus on all types of disabilities. Papers using qualitative and quantitative methods are welcome, as are rigorous systematic reviews and policy analysis. We are particularly interested in papers that make use of causal inference research designs, though we also welcome high-quality descriptive work. While submissions focusing on all age groups are welcome, we anticipate that the bulk of the special supplement will focus on people with disabilities under age 65, owing to their underrepresentation in other work. Priority will be given to submissions that include researchers with disabilities. Topics with a community living policy focus for this issue include, but are not limited to, the following: experiences, disparities and outcomes of individuals receiving, and outcomes of HCBS, accessible housing, direct support workforce and caregiver supports, and employment.

- <u>CALL FOR PAPERS</u>: Drs. Lesley Tarasoff and Hilary Brown are Co-Guest Editors for a special collection for <u>Archives of Women's Mental Health</u> on Disability and Mental Health Across the Reproductive Life Course. <u>The call for papers can be found here</u>.
 - a. We are looking for original research, systematic reviews, and short communications investigating mental health outcomes and mental health care experiences among women with disabilities related to the menstrual cycle, fertility/conception and pregnancy, postpartum and parenting, and the menopausal transition. We will consider quantitative study designs on populations with physical, vision, hearing, and intellectual or developmental disabilities. We encourage the submission of interdisciplinary studies, studies that examine the intersections of ableism and other forms of oppression such as racism, and studies from all global contexts.
 - b. The submission deadline is November 30, 2023. Given your expertise, we hope that you will consider submitting your work. We would also appreciate it if you could circulate this call to others who may be interested.

Disability and Health Journal Featured Article

- Caldwell, J., Heyman, M., Katz, G., & Ho, S. (2023). <u>Facilitators and barriers to person-centered</u> planning from the perspectives of individuals receiving medicaid home and community-based services and care managers. Disability and health journal, 101473.
 - This study explored the experiences of individuals receiving Medicaid HCBS and care managers facilitating person-centered planning in three states to learn from their perspectives of facilitators and barriers through semi-structured interviews. From the perspectives of individuals receiving HCBS, facilitators to person-centered planning included: choice and control, personal goals and strengths, and relational communication. Care managers similarly identified the importance of relational communication, but also identified the development of measurable goals. Barriers from the perspectives of individuals receiving HCBS included: medical orientation of care plan, administrative and systemic barriers, and competencies of care managers. Care managers similarly identified administrative and systemic barriers.

 - "Multiple obituaries have summarized Judy's impressive professional achievements and the childhood origins of her persona as an "unrepentant disability rights activist." She left a treasure trove of commentaries on her life and work, including her 2020 memoire, a TED talk, and "The Heumann Perspective" – podcasts and multiple YouTube videos. Judy needs little introduction to most Disability and Health Journal readers, and in any case, a brief essay cannot do justice to a lifetime of such consequence. Instead, here I highlight five areas where Judy's legacy and experiences hold special implications for researchers studying disability."
